Pursuant to and in accordance with Hawai'i Rule of Civil Procedure 58, and with the Court being fully advised in the premises, and with good cause appearing therefore, IT IS HEREBY ORDERED, ADJUDGED, and DECREED that FINAL JUDGMENT IS ENTERED pursuant to and in accordance with the Court's <u>September 20</u>, 2021 Order Granting Final Approval of Settlement and Motion for Approval of Attorney Fees, Costs, and All Other Expenses.¹

Final judgment is entered as to the settlement and release of all counts and claims of this action, including all counts and remedies claimed in the operative Class Action Complaint, filed August 20, 2013;

On February 1, 2016, the Court dismissed all of Third-Party Plaintiffs Castle & Cooke Waikoloa, LLC and Castle & Cooke Homes Hawaii Inc.'s (jointly "Castle & Cooke") third-party counts and claims in the Third-Party Complaint against Third-Party Defendant Uponor, Inc.;

This class action involved allegations of defective brass fittings PEX plumbing systems in homes built by Castle & Cooke Homes Hawaii, Inc. and Castle & Cooke Waikoloa LLC in the housing developments known as Kikaha at Wehilani and Makana Kai and Wehilani that were completed by or after August 20, 2003 and which contain the brass fittings at issue in the lawsuit. The *Waikoloa-PEX Brass Fittings* Settlement has been approved and is hereby implemented, including the releases set forth herein. There are no remaining *Waikoloa-PEX Brass Fittings* Class Member Claims, defenses, or parties; and

All parties in the Lawsuit are to bear their own fees and costs except as is set forth in the *Waikoloa-PEX Brass Fittings* Settlement, herein, and in the prior orders of this Court.

This final judgment resolves all claims, counterclaims, and cross-claims by and against all parties in the above-entitled case and no claims, counterclaims, cross-claims, or parties remain. All claims, counterclaims, and cross-claims not specifically identified herein are hereby dismissed.
